LED indicators

LED indicator	Description
PWR	Solid on: Powered on
	Off: Powered off
Link/Act (RJ-45 port) *Above the RJ-45 port, the left side is 2.5G, and the right side is 1G. Link/Act (SFP+ slot) *Under the SFP+ slot	Solid on: Connected but without data transmitting Blinking: Connected and data transmitting Off: Not connected
	-Ç-Tips -Link/Act (RJ-45 port): Green light indicates the port negotiation rate is 2.5 Gbps. Orange light indicates the port negotiation rate is 1 Gbps or 100 Mbps. -Link/Act (SFP+ slot): Green light indicates the port negotiation rate is 10 Gbps. Orange light indicates the port negotiation rate is 2.5 Gbps or 1 Gbps.

Working mode toggle

Working mode	Description
Standard	Default mode. In this mode, all ports can communicate with each other.
VLAN (for TEM2010X)	In this mode, ports 1-6 are isolated from each other, but all of them can communicate with ports 7-10.
Static aggregation (for TEM2010X)	In this mode, ports 7–8 belong to aggregation group with a maximum rate of 5 Gbps. It is commonly used for the connection between a switch and a server (such as Ethernet NAS) to provide the server with exclusive high bandwidth.


Install the device

Preparations

- Desktop mounting: ESD bracelet or gloves
- Wall mounting: ESD bracelet or gloves, screwdriver, spirit level, marker, hammer drill, rubber hammer, ladder, 2 screws (thread diameter: 3 mm, length: 14 mm; Head diameter: 5.2 mm), 2 expansion bolts (height: 6.6 mm, inner diameter: 2.4 mm, length: 26.4 mm).

■ Desktop mounting


Horizontally place the switch right-side up on a big enough, clean, stable and flat desktop.



■ Wall mounting

✓ Not

- The switch can only be installed on non-flammable walls, such as a concrete wall.
- Do NOT install the switch with air vents facing downward; otherwise, there will be potential safety hazards.
- 1. Use a hammer drill to drill 2 holes (diameter: 6 mm) on the wall and the distance between the 2 holes is 113.50 mm. Keep the two holes on a horizontal line.
- Knock the expansion bolts into the holes using a rubber hammer. Use a screwdriver to fix the screws into the expansion bolts.
- The distance between the inside surface of the screw header and the edge of the expansion bolt should not be less than 2.5 mm, to make sure that the switch can be hung on the screws firmly
- 3. Align the two wall-mounting slots on the bottom of the switch with the two screws on the wall, and then slide the switch to fit in the screws until it is firmly hung on the screws.





Typical network topologies


· Ó- Tips

- The switch supports auto MDI/MDIX. You can connect the switch to Ethernet devices by using either a straight-through cable or a crossover cable.


■ Standard mode (default)

FAQ

Q1: The PWR LED indicator does not light up. What should I do?

- Ensure that the power adapter is connected to the switch and the power socket properly.
- Ensure that the power socket is powered on.
- Ensure that the input voltage matches the value required by the switch.

Q2: The Link/Act LED indicator of the switch is off. What should I do?

- Ensure that the cable between the switch and the attached device is connected properly.
- Ensure that the cable is not damaged, and the length of the cable meets the requirements.
- Ensure that the switch is powered on.
- Ensure the connected device is powered on and working properly.
